 - **b.** Pilot of Paid Medical Leave Pool launched July 1. Applies to staff who have exhausted all medical leave and those caring for others.
 - i. What documentation does a staff member need?
 - Application is located on the OSU-HR website. Documentation will be sent to HR for review, and from here HR will review and approve/deny the request. Department will be notified similar to FMLA procedures.
 - **ii.** Staff are required to be employed for two years to apply. All other leave pools must be exhausted in order to qualify.
 - **c.** Staff Sick Leave Highlights:

- i. Included definition of illness to include mental health.
 - 1. What constitutes mental health?
 - a. OSU-HR will not "get into the weeds" on this endeavor. Staff will solely be required to state they are taking a mental health day. If a staff member takes more than 3 consecutive mental health days, departments are allowed to request an explanation and/or doctors notes.
- ii. Foster children now classified as immediate family.
- **iii.** Those with a sick leave balance of 960 hours can now utilize these hours as one year of service toward retirement. Applies to both OTRS and TIAA.
