Budget

- We are down around 500 students. They are gathering information still, but it appears that freshmen enrollment is not down. It appears that the "Finish in 4" campaign is working so we are not seeing the 5th and 6th year seniors contribute to our budget.
- There will be budget challenges within each college.
- Governor Stitt has expressed much interest in research benefitting the state. We are currently sending proposals regarding research missions to capture \$3 million in new funding being provided by the state.
- Currently there is no raise program in place for staff. President Hargis, VP Weaver and Provost Sandefur are all in favor of a raise program but with the current situation of the budget, there is no room to allow for a raise program. They are planning to roll out some kind of program in the near future/

Construction

- Performing arts center is now open. Call the schedule a tour of the new state of the art facility. Grand opening is set for October 12 featuring the **New York Philharmonic.**
- They are underway on the new Music school
- New fire training building we be starting soon.
- Starting renovations on Engineering South similar to what they did to Engineering North.
- Projected to build a new flight center in 2020.
- Kerr-Drummond will be coming down- prior to demolition, a location will need to be determined for the residential dining area located in the mezzanine.
- Boomer creek project is underway. OSU partnered with ODOT to restructure the drainage ditch along Duck to allow proper drainage during heavy rainfall.
- OSU Athletics have acquired some residential properties on the southeast/east side of GIA to create surface parking areas for Athletic events.

OSU-OKC Vice Chair Report August 6, 2019

Futsal Court- We have partnered with Oklahoma City's soccer team, Energy and their Assist Foundation. We have constructed our very own Futsal court that we plan on opening up to our community around us as well as our students.

Choctaw Nation— OSU-OKC was presented an opportunity to collaborate with the Choctaw Nation Career Development Office in the interest of designing a strategy to present academic degree programs to over 12,000 Choctaw tribal citizens residing in Oklahoma and Cleveland counties. We will be adding them to the offices by Enrollment.

Late Enrollment Hours— We are currently in extended hours for Fall enrollment and are open on Saturdays until the start of school.

Regents Office— They are now housed with us on the campus with after moving from the Department of Agriculture over by the Capital. This move started last month.
